2. No Call Locking will be entertained (in/out stationed). If at all it is required then it will be performed by local Maintenance Engineer.
3. Testing of the product onsite is mandatory
4. In no case, the suppliers shall be provided with remote access of the servers.
5. It is mandatory to quote for above given optional, else the quotation may be rejected.
6. Reporting time should not be more than 2 hours

- The institute is exempted for payment of Excise duty under notification No. 10/97 & partially custom duty (@5.15%), under notification 51/96 and a road permit will be provided, if applicable. The Concessional Form 'C/D' have been abolished w. e. f. Apr 01, 2007.
