1. **Weighing Capacity** : 100/220 grams (dual mode)

2. **Readability** : 0.01/0.1 mg

3. **Linearity** :  $\leq \pm 0.03/0.2/0.1 \text{ mg}$ 

4. Response Time :  $\leq 12/3 \text{ sec}$ 

5. **Repeatability** :  $\leq \pm 0.02/0.1 \text{ mg}$ 

6. Pan Size : 80 mm dia
7. Operating temperature : 10 – 45° C
