**INSTRUCTION FOR ONLINE BID SUBMISSION**

The bidders are required to submit soft copies of their bids electronically on the Central Public Procurement (CPP) Portal ie <http://eprocure.gov.in/eprocure/app> , using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

**1. REGISTRATION**

- (i) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:<https://eprocure.gov.in/eprocure/app>) by clicking on the link “Online Bidder Enrolment” option available on the home page. **Enrolment on the CPP Portal is free of charge.**
- (ii) During enrolment/ registration, the bidders should provide the correct/ true information including valid email-id & mobile no. All the correspondence shall be made directly with the contractors/ bidders through email-id provided.
- (iii) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (iv) For e-tendering possession of valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) is mandatory which can be obtained from SIFY /nCode/eMudra or any Certifying Authority recognized by CCA India on eToken/ SmartCard.
- (v) Upon enrolment on CPP Portal for e-tendering, the bidders shall register their valid Digital Signature Certificate with their profile.
- (vi) Only one valid DSC should be registered by a bidder. Bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse and should ensure safety of the same.
- (vii) Bidders can then log into the site through the secured login by entering their userID/ password and the password of the DSC/ eToken.

**2. SEARCHING FOR TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords, etc., to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

**3. PREPARATION OF BIDS:**

- (i) For preparation of bid Bidders shall search the tender from published tender list available on site

and download the complete tender document and should take into account corrigendum if any published before submitting their bids.

After selecting the tender document same shall be moved to the 'My favourite' folder of bidders account from where bidder can view all the details of the tender document.

- (ii) Bidder shall go through the tender document carefully to understand the documents required to be submitted as part of the bid. Bidders shall note the number of covers in which the bid documents have to be submitted, the number of documents – including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- (iii) Any pre-bid clarifications if required, then same may be obtained online through the tender site, or through the contact details given in the tender document.
- (iv) Bidders should get ready in advance the bid documents in the required format (PDF/xls/rar/dwf/jpg formats) to be submitted as indicated in the tender document/schedule. **Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.**
- (v) Bidders can update well in advance, the documents such as experience certificates, annual report, PAN, EPF & other details etc., under "My Space/ Other Important Document" option, which can be submitted as per tender requirements. This will facilitate the bid submission process faster by reducing upload time of bids.

#### **4. SUBMISSION OF BIDS:**

- (i) Bidder should log into the site well in advance for bid submission so that he/ she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay.
- (ii) Bidder should prepare the EMD as per the instructions specified in the NIT/ tender document. The details of the DD/BC/BG/ others physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- (iii) While submitting the bids online, the bidder shall read the terms & conditions (of CPP portal) and accepts the same in order to proceed further to submit their bid.
- (iv) Bidders shall select the payment option as offline to pay the EMD and enter details of the DD/BC/BG/others.
- (v) Bidder shall digitally sign and upload the required bid documents one by one as indicated in the tender document.
- (vi) Bidders shall note that the very act of using DSC for downloading the tender document and uploading their offers is deemed to be a confirmation that they have read all sections and pages of the tender document without any exception and have understood the complete tender document and are clear about the requirements of the tender document.
- (vii) Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document. For the file size of less than 1 MB, the transaction uploading time will be very fast.
- (viii) **If price quotes are required in XLS format, utmost care shall be taken for uploading Schedule of quantities & Prices and any change/ modification of the price schedule shall render it unfit for bidding.**

**Bidders shall download the Schedule of Quantities & Prices i.e. Schedule-A, in XLS format and save it without changing the name of the file. Bidder shall quote their rate in figures in the appropriate cells, thereafter save and upload the file in financial bid cover (Price bid)**

**only.**

**If the template of Schedule of Quantities & Prices file is found to be modified/corrupted in the eventuality by the bidder, the bid will be rejected and further dealt as per provision of clause no 23.0 of ITB including forfeiture of EMD.**

**The bidders are cautioned that uploading of financial bid elsewhere i.e. other than in cover 2 will result in rejection of the tender.**

- (ix) Bidders shall submit their bids through online e-tendering system to the Tender Inviting Authority (TIA) well before the bid submission end date & time (as per Server System Clock). **The TIA will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders at the eleventh hour.**
- (x) After the bid submission (i.e. after Clicking “Freeze Bid Submission” in the portal), the bidders shall **take print out of system generated acknowledgement** number and keep it as a record of evidence for online submission of bid, which will also act as an entry pass to participate in the bid opening.
- (xi) Bidders should follow the server time being displayed on bidder’s dashboard at the top of the tender site, which shall be considered valid for all actions of requesting, bid submission, bid opening etc., in the e-tender system.
- (xii) All the documents being submitted by the bidders would be encrypted using PKI (Public Key Infrastructure) encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology.

**INSTRUCTION FOR e-PROCUREMENT**

**1. PREPARATION AND SUBMISSION OF BIDS :**

- a. The detailed tender documents may be downloaded from <http://eprocure.gov.in/eprocure/app> till the last date of submission of tender. The Tender may be submitted online through CPP Portal <http://eprocure.gov.in/eprocure/app>
- b. The bidder should submit the bid online in two parts viz. Technical Bid and Financial Bid. Technical Bid should be upload online in cover 1 and Financial Bid in “.Xls” should be upload online in cover-2

**2. SUBMISSION OF THE BID :** All interested eligible bidders are requested to submit their bids online on CPP Portal: <http://eprocure.gov.in/eprocure/app> as per the criteria given in this document:

- a. Technical Bid should be upload online in cover-1.
- b. Financial Bid should be upload online in cover-2

Both Technical and Financial Bid covers should be placed online on the CPP Portal (<http://eprocure.gov.in/eprocure/app>).

**3. TECHNICAL BID:** Signed and Scanned copies of the Technical bid documents as under must be submitted online on CPP Portal: <http://eprocure.gov.in/eprocure/app>.

- a) **List of Documents to be scanned and uploaded (Under Cover-1) within the period of bid submission:-**
  - i. Scanned copy of Bank details. (Bank details of principal supplier in case of Import shipments)
  - ii. Scanned copy of work experience.
  - iii. Scanned copy of certificate of GST. (GSTIN of Indian Agent in case of Import Shipments)
  - iv. Scan copy of tender acceptance letter.
  - v. Scanned copy of specifications or brochures (if any).
  - vi. Scanned copy of other document mentioned in tender document (if any)
- b) **For Import Shipments – Shipping Terms Ex-Works/FOB are preferred.**

**NOTE - no indication of the rates/amounts be made in any of the documents submitted with the TC-BID.**

**4. Financial Bid**

- c. The currency of all quoted rates shall be INR/USD/EUR.
- d. In preparing the financial bids, bidders are expected to take into account the requirements and conditions laid down in this Tender document. The financial bids should be uploaded online as per the specified “.Xls” format i.e. Price Bid Excel sheet attached as ‘.Xls’ with the tender and based on the scope of work, service conditions and other terms of the Tender document. It should include all costs associated with the Terms of Reference/Scope of Work of the assignment.

- e. The Financial Proposal should be inclusive of all applicable taxes, duties, fees, levies, and other charges imposed under the applicable laws. The rates quoted in the Tender are inclusive of all applicable taxes, duties etc. **except service tax.** The service tax component shall be re-immersible by the department after receipt of paid challans etc. if applicable.

**5. Last Date for Submission of Tender:**

- f. Online bids complete in all respects, must be submitted on or before the last date and time specified in the schedule of events.
- g. The IIT, Kanpur may, at its own discretion, alter/extend the last date for submission of tenders.

**6. Bid Validity**

- a. All the Bids must be valid for a period of 120 days from the last date of submission of the tender for execution of Contract. However, the quoted rates should be valid for the initial/extended period of the Contract from the effective date of the Contract. No request will be considered for price revision during the original Contract period.
- b. A bid valid for a shorter period shall be declared as non-responsive.
- c. In exceptional circumstances, prior to expiry of the original time limit, the IIT may request the bidders to extend the period of validity for a specified additional period beyond the original validity of 120 days. The request and the bidders' responses shall be made in writing. The bidders, not agreeing for such extensions will be allowed to withdraw their bids without forfeiture of their Bid Security.

**7. Modification / Substitution/ Withdrawal of bids:**

- a. No Bid shall be modified, substituted or withdrawn by the Bidder after the Bid's due Date.
- b. Any alteration/ modification in the Bid or additional information supplied subsequent to the Bid's due Date, unless the same has been expressly sought for by the Authority, shall be disregarded.

**8. Rejection of the Bid:** The bid submitted shall become invalid and tender fee shall not be refunded if:-

- a. The bidder is found ineligible.
- b. The bidder does not upload all the documents as stipulated in the bid document.

## **TERMS & CONDITIONS**

1. On-site warranty should be at least 1 year from the date of installation at IITK.
2. Demand draft of Rs.15,000/ (Fifteen Thousand)- towards Bid Security/ EMD in favor of Registrar IIT Kanpur payable at Kanpur must reach **Mechanical Department, Room No. NL-301, IIT-Kanpur, Kalyanpur, IIT Kanpur-208016** latest by 11.03.2020 (14:00 hrs) in a sealed envelope super scribed Tender ID, Tender enquiry no. dated and Bid opening date.
3. Vendor must provide separate quotes for a) camera + accessories (frame grabber, power adaptor, triggering and data-transfer cables, software, drivers etc), b) imaging lens (optional) and c) calibration target (optional).
4. Vendor must provide the details of users of the quoted items in India.
5. Complete literature/specifications on the quoted model should be attached.
6. Quotation should carry proper certifications like proprietary certificate or authorization certificate from manufacturer.
7. The delivery period should be specifically stated. Six weeks or earlier delivery will be preferred.
8. Quotation may indicate CIF prices as well as Ex-Works with shipping terms.



9. Payment terms & condition as per institute (IITK) norms.
10. The supplier shall provide the banking details along with their letterhead duly signed and stamped.
11. Any request for changing banking details will be accepted only if the vendor provides an indemnity bond certificate by the bank for the same.
12. Validity of quotation should be at least for 120 days.
13. All equipment must be compatible with Indian electrical standards and codes. Engineering documentation on the physical sizes and weights of all major and minor components must be submitted.
14. Case or covering bags to keep the product safely should be provided
15. Supplier should support the installation of the complete setup.
16. IIT Kanpur is fully exempted from payment of GST on Imported Goods against our DSIR certificate.

# **SPECIFICATIONS OF CCD CAMERA FOR PIV APPLICATION:**

## **a) Camera + accessories**

1. Interfaces Available: Camera Link® Base/Medium and/or USB3 and/or GigE Vision
2. Sensor: CCD, Monochrome
3. Camera should be able to work in PIV (double-exposure) mode.
4. Sensor resolution: 9 megapixels or higher
5. Pixel Size: less than 4  $\mu\text{m}$
6. Frame Rate: 15 fps or higher at full resolution in single-exposure mode
7. Regions of Interest (ROI): User should be able to specify multiple flexible ROIs, any line to any line, any pixel to any pixel
8. Frame rates higher than 50 Hz should be possible with smaller ROIs.
9. Output Format: 8 bit, 10 bit, 12 bit at full resolution
10. Minimum exposure time: 2 microseconds or smaller is desirable.
11. Exposure time should be settable in increments of 1 microsecond.
12. Exposure Control: Manual, auto, external
13. Trigger Inputs: User should be able to trigger the camera externally using a signal generator
14. Trigger Modes: Free-run, standard, double
15. Double Trigger (PIV) Interframe Time: Less than 500 nanoseconds desirable
16. A programmable RS232 Interface for the camera is desirable
17. Lens Mount: C-Mount/F-mount
18. Operating conditions: up to min 80 degree C
19. Front cap and protective case for the camera must be provided.
20. All camera accessories should be included, e.g. frame-grabber, power adaptor, data transfer cables, triggering cables, softwares, drivers etc.
21. Imaging software should work on Windows platform.
22. The image acquisition software must be able to work with an independent external triggering system/pulse generator.
23. Calibration routine (also for 2D-2C PIV with oblique imaging) in the imaging software is desirable.

## **b) Imaging lens (optional)**

1. The lens should preferably have an in-built tilt/shift mechanism.
2. Adapters to mount the lens on the camera, if necessary, should be included.
3. Desirable maximum magnification  $\geq 0.5$ .
4. Lens covers (front and back) and protective case should be provided.

## **c) Calibration target (optional)**

1. Calibration target that can work for both plane- and volumetric-PIV is desirable.
2. Desirable calibration target size: approx. 100 mm  $\times$  100 mm.
